### **CWA Winery Membership Benefits:**

  and winegrape growers in producing the highest quality product and press relations to
  foster consumer awareness and recognition of the Calaveras Wine Region. At the end of

  email and social media outlets.

### Wineries are expected to:

- Donate wine for promotional and political purposes annually. Wines will be used for Fundraising Events (Calaveras County Fair & Grape Stomp), Trade Shows, Wine Tastings, Press Tours and other promotional/political purposes. Occasionally wines may be used for CWA donation baskets or in cooperation with our community partners.
- Help promote CWA Events through email and social media campaigns as it makes sense. Winery members are asked to display and share CWA promotional materials such as: event posters and flyers, CWA brochures and maps. The CWA administrative team agrees to provide these materials in a timely manner to accommodate marketing deadlines.

#### Annual Membership Dues:

\$1000 per year for one tasting room and \$1500 per year for 2+ tasting rooms. Annual dues are billed quarterly, and online payment services are available as needed. NOTE: 50% deposit is due at the time of signing for new winery memberships and is applied towards 1<sup>st</sup> and 2<sup>nd</sup> quarter dues. Note: all annual memberships are set to auto renew.
